

### PEER REVIEW PROGRAM

Even though members do their very best to eliminate the dental problems of their patients, there will always be the case where a patient believes that he/ she has not received quality dental care. If this situation arises, members are encouraged first to try to reach a resolution with the patient. Should that effort be unsuccessful, the MDA offers a public service known as Peer Review. The Peer Review program has been very effective in eliminating the necessity of legal proceedings to settle disputes regarding dental care.


# **District Dental Societies**

The Mississippi State Board of Dental Examiners is a legislatively-mandated state regulatory agency charged with the responsibilities of examining, licensing, registering, and regulating the practices of dentistry and dental hygiene to ensure competency (through examination and licensure) and ethics (through registration and regulation) among all dental professionals in the State of Mississippi for the ultimate goal of safeguarding and enhancing the health and welfare of the citizens of this State. As such, the Mississippi State Board of Dental Examiners is neither affiliated with nor functions as a subsidiary of any private or professional organization.

# **YOUR OFFICE OPERATIONS**

### TAXES

#### **Personal Property**

County tax assessors can provide personal property tax worksheets to list tangible assets, such as equipment and furnishings, used in dental practices.

#### Employee

Dentists are required to withhold certain taxes from each employee's paycheck. Dentists in business for themselves are advised to consult an accountant. Required taxes include: federal, Medicare, Social Security and federal unemployment as well as state taxes.

### **REQUIRED POSTERS**

#### State Posters

The Mississippi Department of Employment Security (MDES) provides the Job Insurance Poster by downloading it from the Web site, or by calling (601) 321-6146. You may also contact your local tax

field representative to obtain this poster. The poster is available at no charge.

The only other State required poster is the Mississippi Worker's Compensation poster. This poster is available by visiting the Mississippi Worker's Compensation Web site.

### **Federal Posters**

Posting requirements vary by statute; that is, not all employers are covered by each of the Department's statutes and thus may not be required to post a specific notice. For example, some small businesses may not be covered by the Family and Medical Leave Act and thus would not be subject to the Act's posting requirements.

### Health Insurance Portability and Accountability Act (HIPAA)

The HIPAA Privacy Rule provides federal protections for individually identifiable health information held by covered entities and their business associates and gives patients an array of rights with respect to that information. At the same time, the Privacy Rule is balanced so that it permits the disclosure of health information needed for patient care and other important purposes.

The Security Rule specifies a series of administrative, physical, and technical safeguards for covered entities and their business associates to use to assure the confidentiality, integrity, and availability of electronic protected health information.

HIPAA materials are available through the ADA catalog.

### National Provider Identifier (NPI)

The National Provider Identifier is a unique, government-issued, standard identification number for individual health care providers and provider organizations such as clinics, hospitals, schools and group practices. NPIs that specify an individual, such as a solo practice dentist, are classified as Entity Type 1 (Individuals) NPIs. NPIs that specify a dental practice organization are classified as Entity Type 2 (Organizations) NPIs.

Any health care provider that uses electronic transactions—like claims or eligibility verifications—is considered a "covered entity" under the Health Insurance Portability and Accountability Act ("HIPAA") standard and is required under federal law to include an NPI on electronic transactions. This definition applies regardless of whether the provider submits electronic transactions directly or via a third party, like a vendor or a clearinghouse.
