## First Presentation

### “The CAD/CAM Ceramic Update”

CAD/CAM ceramics are used extensively in patient treatment. This lecture focuses on describing the classification of CAD/CAM ceramics, and it highlights recent innovations in traditional and hybrid ceramics. Clinical scenarios will be displayed to highlight practical applications of them.

#### Learning Objectives:

- Understand the classification and composition of today's CAD/CAM dental ceramics.
- Develop an understanding of the advantages and limitations for each type of ceramic.
- Apply knowledge towards selection of the material prior to patient treatment.

## Second Presentation

### “Minimally Invasive Veneer Restorations”

It has been demonstrated that conservative restorative techniques rely on bonding and adhesive luting, because intact enamel provides the most reliable substrate for etched ceramic laminate veneers. Therefore, the use of tooth reduction guides is highly recommended in order to create ideal adhesive and to prevent excessive reduction that can lead to compromised bond strength due to penetration of the dentin.

#### Learning Objectives:

- Understand the importance of minimally invasive tooth preparations.
- Develop an understanding of the different types of reduction guides available for anterior teeth.
- Apply knowledge towards fabricating traditional and 3D printed tooth reduction guides.
